



INDIVIDUAL RV PARKS AND CAMPGROUNDS

2018 Rate Schedule

I. ANNUAL FEE PER RV PARK OR CAMPGROUND FOR CALENDAR YEAR 2018

The annual license fee per RV park or campground for calendar year 2018 shall be computed on the following basis: (i) the fee based on the number of campsites, plus (ii) the fee based on live entertainment costs (if any).

(A.) FEE BASED ON NUMBER OF CAMPSITES FOR CALENDAR YEAR 2018

<u>Number of Campsites*</u>	<u>Annual Fee</u>
1 to 99	\$ 277.00
100 to 149	\$ 391.00
150 to 249	\$ 522.50
250 to 349	\$ 678.00
350 and over	\$ 845.50

For seasonal licensees, the license fee based on the number of campsites for periods up to four months of operation is ½ the annual fee; for each additional month the fee is 1/12 the annual fee; provided, however, that the annual fee per RV park or campground for 2018 shall not be less than \$235.50. The seasonal fee based on the number of campsites will in no case be more than the annual fee based on the number of campsites.

*The term "campsites" includes, but is not limited to, tent sites, RV spaces and designated lodging areas located at the premises.

(B.) FEE BASED ON LIVE ENTERTAINMENT COSTS FOR CALENDAR YEAR 2018

For "live" entertainment, the fee shall be the amount set forth below which corresponds to the "Live Entertainment Costs" (as defined in subparagraph "3.(c)" of the Agreement) for the calendar year:

\$2,000.00 to \$4,999.99	\$ 304.00
\$5,000.00 to \$9,999.99	\$ 458.50
\$10,000.00 to \$14,999.99	\$ 598.50
\$15,000.00 to \$24,999.99	\$ 905.50
\$25,000.00 to \$34,999.99	\$1,200.00
\$35,000.00 to \$49,999.99	\$1,494.50
\$50,000.00 and Over	*

II. ANNUAL LICENSE FEE FOR CALENDAR YEAR 2019 AND THEREAFTER

The annual license fees hereunder for each calendar year commencing 2019 shall be the license fees for the preceding calendar year adjusted in accordance with the increase in the Consumer Price Index, All Urban Consumers - (CPI-U) between the preceding October and the next preceding October.

*If "Live Entertainment Costs" as defined in subparagraph "3.(c)" of the Agreement exceed \$50,000.00 in any calendar year, contact SOCIETY for quotation of applicable fee.
